Year Levies

- **Prep and Year 1 Levy** - \$250 per child (will be charged evenly over 4 terms)

School fees and levies are generated on a termly basis. Statements are emailed to families within the first two weeks of term from pyerfinance@bne.catholic.edu.au to each account holder. The due date for payment will be 14 days after the statement is issued.

Additional School Fees

- School Camps (Years 4, 5 and 6)

Parents will be advised in advance of the cost, and it will be added to the fee statement for the term in which the camp is occurring.

Confirmation of Enrolment Fee

A non-refundable fee of \$200 per student will be charged when the enrolment of the student is confirmed. The fee consists of a \$50 enrolment application fee and a \$150 enrolment confirmation fee that upon commencement, will be credited to the first Statement of Fees issued.

Methods of Payment – School Fees

Our preferred method of payment is via Direct Debit. The Direct Debit Form is available on the parent portal under documents – Finance/Fees.

Payments can be made through an agreed payment plan that is arranged with the school Finance Office to allow families to meet their commitments by weekly, fortnightly, or monthly payments. Usually, these payment arrangements are by direct debit from a nominated bank account.

Other accepted methods of payment include:

- EFTPOS – Debit and Credit Cards at the school office, (Note: via phone no longer accepted)
- BPAY
- BPoint
- Agreed Payment Plan by Direct Debit

Please note: The school does not accept cash payments.

Explanation of Fee and Levies

Tuition Fee	Contributes to costs associated with teaching and administration; classroom support and facilities; resources and equipment; maintenance of buildings and grounds; electricity, rates, and telecommunications; cleaning and consumables; and insurance.
General Purpose & Co-Curricular Levy	Contributes to costs associated with student activities and curriculum resources, such as: sports equipment and carnivals; swimming lessons and carnival; bus transport; excursions and incursions, teacher and library resources and events; Religion resources; subscriptions and guest speakers; student welfare, first aid and office supplies; graduation and school celebrations.
Capital Levy	Contributes to costs associated with capital loan repayments and capital expenditure on school buildings, grounds, and equipment.
Technology Levy	Contributes towards the cost of the technology within the school including warranty and insurance; software licences and internet servers; infrastructure to support network connectivity and internet access.
1:1 Device Levy	Contributes to costs associated with the purchase and maintenance of iPad devices and accessories.
Prep/Year 1 Levy	Contributes to our child centred, play based approach to early childhood learning by providing additional resources and staffing.
Library Fund	Is a fully tax deductible donation to support the purchase of new resources for the library. A tax statement will be issued each July for the previous financial year.
